GENERAL GUEST GUIDANCE

ARRIVAL INSTRUCTIONS

Personal Vehicles & Private Chauffeured Vehicles:

- Prior to entering Mar-a-Lago, please go through a Security Check at the Bath & Tennis Club parking lot (1) and have your IDs and QR codes ready. You will need to exit the vehicle for a quick sweep by the USSS.
- Enter the property via the Southern Blvd. Gate (2).
- Utilize the Club's Valet service to park your vehicle (3).

Shuttles:

- Prior to entering Mar-a-Lago, shuttle will go through a Security Check at the Bath & Tennis Club parking lot (1). Have your IDs and QR codes ready.
- Shuttle will enter the property via Southern Blvd. Gate (2).

Rideshare:

Please be advised that Uber, Lyft and any other rideshares are not allowed at The Mar-a-Lago Club. If you are utilizing a rideshare service please adhere to the following policy:

- Instruct drivers to drop off at the Southern Blvd. gate.
- Upon arrival, have your IDs and QR codes ready.
- A golf cart will be provided.

DEPARTURE INSTRUCTIONS

Personal Vehicles & Private Chauffeured Vehicles:

- Pick up your vehicle at the Valet and exit the property via the Southern Blvd. Gate.

Shuttles:

- Guest pick up is at the Valet
- Shuttle will exit the property via the Southern Blvd. Gate

Rideshare:

- Instruct drivers to pick up at the white gate on Southern Boulevard.

SECURITY REQUIREMENTS

- The Mar-a-Lago Club utilizes a QR code based system for guest check-in. All guests must provide their first and last name, mobile phone number and/or email to the event organizer 72 hours prior to the event to receive a QR code for entry.
- All guests must present a valid driver's license, military ID, or passport upon arrival.
- Any discrepancy between the name on the guest list and the name on your government-issued ID will delay the entry process.

ELECTRONICS POLICY

The use of electronic devices, including photography in the Main House, Dining Areas, and general Member Areas is strictly prohibited. Photography is allowed in your event space only. Please place your phone on vibrate while on property. Drones are not allowed.


NO SMOKING POLICY

U.S. SECRET SERVICE MAR-A-LAGO SECURITY NOTICE

- The Mar-a-Lago Club is a “restricted area” secured by the U.S. Secret Service pursuant to 18 USC 3056.
- By entering The Mar-a-Lago Club, all members, guests, and vendors are consenting to a search of their person, vehicles, belongings, and electronic devices.
- Failure to consent to a search will result in you being denied entry to the area.
- Persons entering or remaining in the restricted area without lawful authority or invitation are in violation of federal law and will be subject to arrest and prosecution.
- The following items are PROHIBITED:
 - * Firearms
 - * Explosives
 - * Knives
 - * Mace/Pepper Spray
 - * Drones and other unmanned aircraft
 - * Private Security
 - * Weapons of any kind or other items that may be determined to be a potential safety hazard

U.S. SECRET SERVICE PERSONAL ITEMS RESTRICTIONS

- To aid in the efficiency of magnetometer screening checkpoints and operations, the below personal item guidance is provided:
 - * No backpacks, roller bags, or suitcases
 - * Personal item storage size restriction of 10”x7”x3”
 - * No laptops or tablet type devices
 - * No glass, thermal, or metal containers
 - * No books or large poster board signs / banners
